An application to become a citizen of Grenada under the Grenada Citizenship by Investment Programme, pursuant to Section 5 of the Grenada Citizenship by Investment Act, 2013 (Act 15).

### Grenada Citizenship by Investment – Checklist

Proof of source of funds <ul style="list-style-type: none"><li>▪ 12 months personal bank statements (most recent statements).</li><li>▪ Letter of employment, if applicable.</li><li>▪ Required company documents (should be certified), and 12 months company bank statements - 50% and more shareholdings.</li><li>▪ Statement of investments, if applicable.</li><li>▪ Income Tax Statement.</li></ul>	Main applicant or benefactor

15.	Police certificate(s) – (Certified or Apostilled where applicable) From country of birth, and any country the applicant has lived for at least 1 year in the past 10 years –valid for 6 months.	All applicants 17 and older, non-app. spouse, benefactor
16.	Certified color copy of current passport(s) and visa(s) All Pages of the Passport(s) should be submitted and translated where applicable.	All applicants, non-applicant spouse, benefactor
